Jim Talvy reported on the current status of Casella Organics for reclamation project for 38 Root Rd. for Ray Sawyer. Paper fiber will cover 40 acres to both the right and left of main farm area. Application to be submitted at the January 30th meeting. Material to be coming from Irving Paper, and the project will take place Spring 2018.

James McMahon, attorney from State Program for presenting information on Outdoor Cannabis Cultivation was supposed to attend meeting tonight to make a presentation of the details of the program . He did not come. Cathy H. to attend the Conservation mtg. on Jan. 10^{th} ; the next group he is scheduled to meet with, and report back to the board.
