Within 45 days following receipt of the application for a license under this section, the licensing authorities may (a) grant a license or, (b) shall provide the opportunity for a hearing on the application by written notice to the applicant given seven days prior to the hearing date.

Within 30 days next following the final date of such opportunity for a hearing the licensing authorities shall, (a) grant the license or (b) deliver to the applicant a written notice denying the license and stating in writing the reasons for such a denial. No license having been denied as foresaid and no similar application thereto may be filed within one year of said denial except in the discretion of the licensing authorities.
