Dear Director,

The Town of Hubbardston Planning Board is in receipt of an Open Meeting Law Complaint dated December 6, 2018 received on the same date. The Board met on December 12, 2018 to acknowledge the Complaint and consider its response. It met again on December 19, 2018 after which an extension was granted by the OAG to January 11, 2019.

The Complaint alleges the Planning Board violated the OML by the transmittal of a report. A copy of the Complaint is enclosed.

Chronology of Events - June to November, 2018

Following the June 2018 Hubbardston Annual Town Meeting and election, the elected boards took steps to organize, including the appointment of the Planning Board Associate Member. Simply stated, the Planning Board recommends and the Select Board appoints the Planning Board Associate Member per references in MGL and Hubbardston Zoning By-Laws, General By-Laws, and Town Charter. The Select Board and Planning Board did not agree on the appointment process.

This difference of opinion was discussed at the Select Board meeting on June 18, 2018 during which the Select Board decided to defer to the Planning Board. The Planning Board met on July 11, 2018 and publicly voted and designated an associate member. The Planning Board returned to the Select Board meeting on July 23, 2018 and presented its recommended associate member. The Select Board appointed a different person not designated by the Planning Board. This resulted in the July 24, 2018 resignation of the PB Chair. His resignation letter (Ref. B) puts forth the Planning Board's basic position regarding this associate member appointment process.

Since the Select Board meeting of June 18, 2018, the Planning Board has held public meetings properly posted with agendas that included the associate member appointment process or board organization on at least July 5, July 11, Sept 5, Sept 26, and Nov 7. The Planning Board Associate Member Appointment Process was thoroughly discussed in public. In addition, there were Select Board public meetings, sometimes with a Planning Board member present and participating, discussing this Planning Board Associate Member Appointment Process.
