Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 order imposing strict limitations on the number of people that may gather in one place, this meeting of the Hubbardston Select Board will be conducted via remote participation to the greatest extent possible. #### **MUNICIPAL MOSQUITO SPRAYING**

In July 2020, Governor Baker signed into law legislation entitled *An Act to Mitigate Arbovirus in the Commonwealth* (M.G.L. Chapter 252, Section 2A), which requires the Executive Office of Energy and Environmental Affairs (EEA) to develop a process for the State Reclamation and Mosquito Control Board (SRMCB) to permit municipalities to opt out of mosquito spraying, including aerial or other, conducted by the SRMCB.

Discussion from the Board of Health on the benefits of, risks related to, and health impact of Mosquito Spraying.

- XI. **Executive Session: Under Open Meeting Law: Reason 7.** To comply with, or act under the authority of, any general or special law or federal grant-in-aid requirements; There may be provisions in state statutes or federal grants that require or specifically allow a public body to consider a particular issue in a closed session. Before entering

executive session under this purpose, the public body must cite the specific law or federal grant-in-aid requirement that necessitates confidentiality. A public body may withhold that information only if publicly disclosing it would compromise the purpose for which the executive session was called. While we generally defer to public bodies' assessment of whether the inclusion of such details would compromise the purpose for an executive session, a public body must be able to demonstrate a reasonable basis for that claim if challenged.
