Pursuant to the provisions of MGL Chapter 40, Subsection 15C, the Hubbardston Planning Board will hold a public hearing on November 17, 2022 at 6:30 pm or as soon thereafter as the agenda allows in the Town Office, Slade Building, 7 Main St., Hubbardston, on the Scenic Road Application submitted by Ivan Aho for removal of (1) 40" dbh red oak and (1) 36" dbh red oak at 7 New Templeton Rd. Plans may be viewed at the Town Clerk's office during regular business hours.
 - b. Pursuant to the provisions of MGL Chapter 40, Subsection 15C, the Hubbardston Planning Board will hold a public hearing on November 17, 2022 at 6:30 pm or as soon thereafter as the agenda allows in the Town Office, Slade Building, 7 Main St., Hubbardston. The Scenic Road Application submitted by the Town of Hubbardston Highway Dept. is for the removal of 13 trees on Williamsville Rd, listed below. The trees all lie within the Town right of way, and are slated for removal in order to reconstruct the bridge over the Burnshirt River on Williamsville Rd. Plans may be viewed at the Highway Dept office during regular business hours. All trees will be marked seven (7) days before the hearing date.

Trees on westbound side, from west to east: 18" dbh sugar maple, behind utility pole; (2) 18" dbh black locust, before bridge; 32" dbh sugar maple.

Trees on eastbound side, from west to east: 14" dbh black locust; 30" dbh 3-stemmed black locust, before bridge; 10" dbh red maple, edge of river, before bridge; 8" dbh black cherry, after bridge; 12" dbh ash; 12" dbh red oak; 10" birch; 36" dbh red oak, corner of gravel parking area; 40" dbh red oak.
