

# TOWN ADMINISTRATOR'S REPORT

The last few weeks have been extremely busy, with budget season in full swing and spring fever project ideas running rampant. As a result, my calendar has been jam-packed with wonderful meetings and discussions, a few of which I've listed below.

The Economic Development Committee met on February 15 to discuss various initiatives for the coming spring. Several new members are eager to get started with the committee and the Town, and tenured committee members and I are excited to collaborate with them on economic development opportunities.

Select Board Vice Chair Young, and I met with the North Central Chamber of Commerce's CEO and Government Affairs Manager. We talked about how our community can collaborate with the chamber to boost economic development efforts and assist existing businesses, as well as the chamber's One North Central Plan, which aims to inspire the region's public and private sectors to collaborate in building an economically sound and prosperous area capable of benefiting from future growth and development.

I attended the Affordable Housing Committee's first meeting and assisted them in establishing the committee's focus, which is to identify goals and strategies to accomplish and meet the Chapter 40B Comprehensive Permit requirements for affordable housing production in Massachusetts while keeping the natural charm and beauty in mind. The meeting had a lot of conversation, and I look forward to meetings in the future.

Jessica Sizer, the Town Administrator in Barre, and I met to discuss potential money-saving regionalization efforts in which our two communities could participate. This is a discussion I hope to have with all neighboring Town Administrators in the coming months. While it may take time to generate ideas, starting the thought process is worthwhile in the long run.

In mid-February, the Hubbardston Emergency Management Team met to work on the Emergency Continuance of Operations (COOP) plan. We will meet again at the end of the month to discuss this initiative in greater detail.

I met with representatives of the United States Army Corps of Engineers (USACE) to discuss the community's relationship with the Barre Falls Damn. The conversations are intended to help USACE better understand what people in our community know about dams and levees and the

risks and benefits associated with them so that USACE can improve communication with those these structures may impact. This communication channel is open; if residents have any concerns about the dam, don't hesitate to contact my office.

DPW Superintendent Brown and I met with MassDOT Right of Way team representatives to discuss bridge replacement on Williamsville Road over the Burnshirt River, which is scheduled for mid-2024. MassDOT received the 25% project design plans and associated right-of-way plans in November of this year. According to the current project schedule, a Design Public Hearing is scheduled for March 24. To authorize the Select Board to move forward in this initiative, Town Meeting Approval is required, as it was for the Town Center Project. I'm working with legal counsel to draft language for the proposed articles.

#### **Finance**

The finance team and I are working on the FY24 proposed budget. Some variables become clearer with each passing day, such as receiving word that the working number for the dispatch assessment increase should be 15.1%. While the preliminary budget figures are not what we would like to see, we hope that when the Healy Administration releases their budget figures, there will be additional state aid.

The Capital Improvement Plan for 2024-2028 is complete and will be presented to the Hubbardston Select Board on February 21, 2023. I'd like to thank the Capital Improvement Planning Committee for their assistance with this plan. I'm excited to build on it next year!

#### **Grants**

The Montachusett Regional Planning Commission awarded us two DLTA Grants. One will provide technical assistance in preparing proposed zoning changes that will encourage Agri and ecotourism business in the Town in accordance with the Hubbardston Agricultural Accessory Advisory Committee's goals and uses. The second will offer technical assistance in completing previous work on individual chapters of Hubbardston's Master Plan and compiling each chapter into a complete Master Plan document. Thank you to MRPC for their ongoing collaboration with the Town of Hubbardston.

The Commonwealth of Massachusetts awarded us a Municipal Cybersecurity Awareness Grant Program. EOTSS and Proofpoint administer this program, which provides cybersecurity training

and threat simulation (cybersecurity vendor). This training will assist selected employees in detecting and mitigating municipal cyber threats.
